The Uniform Code Council, Inc. (UCC) is a not-for-profit membership organization created in 1972 by industry to administer the Universal Product Code (U.P.C.) used for scanning of bar codes at retail. Today, the UCC serves over 25 industries worldwide offering a full complement of supply chain standards.

To sustain its activities, the UCC relies primarily on membership dues. Originally, dues were for a three-year period. However, acceptance and use of the U.P.C. brought sufficient members into the organization that, in keeping with our not-for-profit structure, we were able to avoid charging members an annual membership renewal fee.

As the demands for services by the industries we serve increased, expenditures have risen to the point that expenses have exceeded revenues for the last several years. Accordingly, our Board of Governors has directed us to implement an annual membership renewal fee. This is the first year of the annual membership renewal fee and, in fairness, the fee has been applied to all new and existing members.

You will be receiving an invoice shortly, which reflects your annual membership renewal fee based on a member company's gross sales revenue and/or the number of unique trade items (products).
